



Hiriye Gift Card

General Terms & Conditions of Use.

1. The Gift Card (hereinafter, the Card) is the property of the issuer Heritage Haute Private Limited, Berhampur, Odisha 760001, Odisha, India (hereinafter, HIRIYE). The holder of the Card is a mere depository.
2. The Card is exclusively valid in India to purchase products being sold in any HIRIYE store or via www.hiriye.com.
3. The price of the Card can be paid by any of the means of payment accepted at the HIRIYE stores or via www.hiriye.com.
4. The return of a Card once purchased shall not be accepted. Any outstanding balance of the Card shall not be refunded or exchanged for cash in any manner whatsoever.
5. The Card can be used as often as the holder would like until the total amount has been used up.
6. The remaining balance on the Card is shown on the cash register receipt every time a purchase is made with the Card, for purchases made at any HIRIYE store, or in the information provided upon placing an order, for purchases made via www.hiriye.com. The remaining balance of the Card may be checked at any HIRIYE store or www.hiriye.com. Where the purchase price is more than the remaining balance on the Card, the difference may be paid through any payment means accepted at HIRIYE stores or www.hiriye.com, as the case may be.
7. Products purchased with the Card at any HIRIYE store shall be subject to the general purchase terms and conditions as any other products purchased at said stores. Products purchased with the Card via www.hiriye.com shall be subject to the purchase terms and conditions shown on the said website.
8. Where appropriate, refund for products purchased with the Card which are returned shall be made by HIRIYE by crediting the price of the returned product back onto the remaining balance of the Card or where the Card no longer exists, upon the return of the products, by crediting the price of such product to a Voucher Card issued by HIRIYE (i) to be handed out in the store, for any refund for products purchased at any HIRIYE store, or (ii) to be sent by e-mail to the address of the customer who purchased that with the Card, for any return of products purchased via www.hiriye.com. Refund methods hereunder provided are an essential term, and as such, they are deemed to be expressly accepted upon purchasing and/or using the Card.
9. The physical Card purchased at any HIRIYE store is valid for 1 (One) year from the date of its purchase, the physical Card bought via www.hiriye.com is valid for 1 (One) year from the date of the shipping confirmation e-mail thereof and the virtual Card purchased via www.hiriye.com is valid for 1 (One) year from the date of its dispatch by HIRIYE to the intended recipient thereof. At the expiry of the validity period, the Card cannot be renewed, or used to purchase products, nor shall any unused remaining balance in the Card be claimed. 2 Sale of these different Card formats shall be subject to their availability in India.
10. The Card is a bearer instrument. Its holder shall be solely responsible for the use and custody of the Card. The Card shall not be replaced in case of theft, loss, or damage thereof. However, HIRIYE may replace the Card in case of a change of format of the Card.
11. Where the virtual Card is purchased via www.hiriye.com, HIRIYE shall not be responsible for the non-receipt or non-activation or the delay in receiving or activation of such Card by its intended recipient on grounds beyond HIRIYE's control, including inter alia: (i) the deficiencies or the breakdown of telecommunications lines/systems, (ii) the delay in the transmission of information or data or the loss of information or data which may occur under any of the circumstances provided under (i) above; (iii) the inaccuracy of the details of the recipient of the virtual Card provided by the purchaser of the Card; (iv) the non-delivery / non-activation or delayed delivery / delayed activation of the Card at the e-mail address provided, or (v) the fact that the e-mail sent by HIRIYE is deemed to be spam or unwanted e-mail.
12. Cards originally obtained through any unlawful means shall be null and void and they shall not be used to purchase products, nor shall the price thereof be refunded. Accordingly, HIRIYE may, in its sole discretion, restrict or stop the use of the Card with immediate effect if suspicious activities are noticed.
13. The Card shall not be used for the purposes of advertising or promoting products and/or services marketed/sold by any third party other than HIRIYE unless prior written consent is given by HIRIYE.
14. The purchase and/ or use of the Card shall be subjected to the guidelines, directions, and circulars, which the Government of India and/ or the Reserve Bank of India, may issue from time to time concerning pre-paid gift cards/instruments.
15. The purchase and/ or use of the Card entails the full acceptance of these terms and conditions, which have been made available to the customer upon purchase of the Card, and which are also available at any HIRIYE store and www.hiriye.com.
